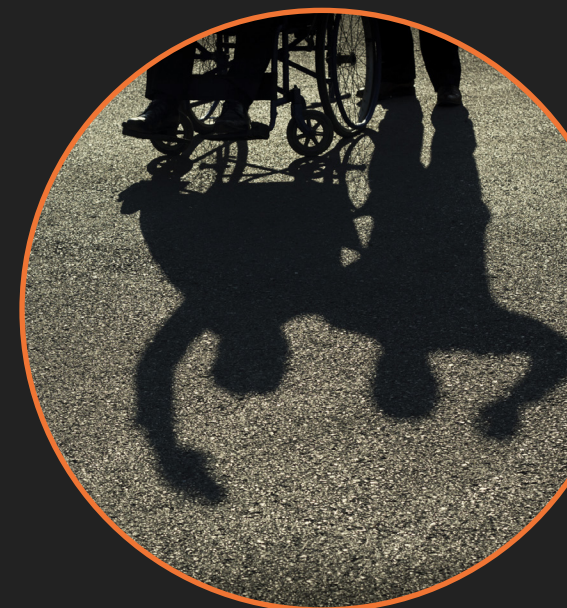

Episodic Coordination of Supports

LifeTransition Planning

We offer short term interventions to support clients who are experiencing significant periods of change, transition and/or, at times when there is an increasing complexity in their situation. In particular, we can offer support to those who may need to transition from disability supports into an aged care setting or for children and young people who are transitioning from the care of the Department of Child Protection & Family Support.

Safeguarding

This includes an advisory service on supported decision-making, guardianship and administration, customised corporate training, assistance with SAT applications and guidance on completion of Enduring Power of Attorney & Enduring Power of Guardianship.
